Dear FBCS Parents:

Thank you for an amazing first half of the school year! There are some exciting things going on at FBCS! We hope you can join us on January 9th at 2:30 for our Spring Preview Day for parents! You will receive lots of information about all the upcoming events!

Good news: Our school committee will NOT be increasing any fees or tuition this year. So here are the expenses:

*For returning students, Registration fees go up to \$550 after March 2nd and again up to \$650 after April 30th. Register early and save \$\$.

**All Building and Technology Fees must be paid by June 5th or will incur an additional 10% increase.

Re-registration Procedures: *Please read carefully as some of the information is different from last year.* Re-registration will begin in January for currently enrolled students. Please print out all of the attached forms, fill them out, and return *all forms* to the office with your registration fee in order to hold your student's spot for next year. The \$450 registration fee for returning students increases on March 3rd to \$550; and on May 4th, the fee increases to \$650.

The deadline to re-register and hold your student's spot on the class roster is Monday, March 2nd. *After March 2nd, we cannot guarantee a spot for currently enrolled students as open enrollment begins on that date and we will begin filling classes at that time with new students.*

Each family will need to sign the Tuition Agreement contract as part of the re-registration process at the time of registration unless paying in full at that time. If you decide to pay in full by **June 5th**, the contract will be null and void. If you pay

after June 5th, the contract will already be in effect and the 10% interest fee will apply. To help clarify: Please sign the FBCS Tuition Agreement or pay your tuition payment in full at the time of re-registration. If you are paying tuition in full at a later date but by June 5th, we will shred your contract when we receive the payment. Any monies paid towards tuition before June 5th will be deducted from your contract. The 10% finance fee will only be applied against the remaining balance. Those of you paying in full after the deadline will incur the 10% finance fee.

As always, if you are having financial issues and need an extension, please come to the office and speak with Mrs. Vickie Odom and we will work with you.
